Still Need Renewal Training?

June 30th has come and gone. You should have already received a renewal notice in the mail from the State and taken at least four hours of approved training so that you can renew your ODEQ water and/or wastewater certifications. If you still need to get your annual 4 hours of renewal training, Accurate Environmental Training Center has several opportunities to get your training in by the end of July.
